ADDENDUM

Kindly refer to advertisement No. 2-1/2022/Rectt.Cell/Administrative(CBT) dated 07/05/2022. The following are added under para 6 & 7:

- (i) Para- 6 (Age relaxation for ex-servicemen)-In pursuance of compendium of instruction for ex-servicemen issued vide O.M. 36034/3/2013-Estt.(Res.) dated 25.02.2014, the upper age limit is relaxed by the length of military service increased by 03 years in the case of ex-servicemen.
- (a) On completion of assigned (including those whose assignment is due to be completed within one year) otherwise than by way of dismissal or discharged on account of misconduct or inefficiency or
- (b) On account of Physically disability attributed to military service or on invalidment shall be allowed maximum relaxation of 5 years in the upper age limit.
- (c) The applicant seeking age relaxation under this category shall invariably submit the requisite certificate as per Appendix- 2&3 enclosed with O.M. 36034/2/91-Estt. (SCT) dated 03.04.1991 issued by DoPT.
- (ii) Para -7 (application fee for Ex-servicemen) - application fee is payable Rs. 1200/- plus transaction charge as applicable.
