In continuation of earlier Notice No. ICAR-IARI/Dte-PGS-I/3-8/2021 dated July 30, 2022, it is hereby announced for the general information of all M.Sc./M.Tech. and Ph.D. candidates who have been declared qualified in the entrance examination conducted by NTA/ICAR on September 20, 2022 and **if eligible for any of the Schemes** given below are advised to fill up application form and upload required documents online for filling up seats under Different Schemes at IARI, New Delhi (*which shall be over and above the quota generally fixed*) viz. (1) *Faculty Upgradation Scheme (FUS)*, (2) *ICAR In-Service Scheme*, (3) *Departmental (Scientific and Technical) Scheme*, (4) *Children/Widows of Security Forces (CWSF) Scheme* and (5) *Wards of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu families (Non-Migrants) living in Kashmir Valley*.

INSTRUCTIONS FOR FILLING UP APPLICATION FORM AND UPLOADING OF
REQUIRED DOCUMENTS ONLINE FOR M.Sc./M.TECH. AND PH.D. DEGREE
PROGRAMMES UNDER DIFFERENT SCHEMES AT IARI, NEW DELHI FOR
ACADEMIC SESSION 2022-23

Note: Read the Eligibility Conditions for Different Schemes. If you meet the Eligibility Conditions, proceed for Filling up of Application Form and Uploading of Required Documents Online for M.Sc./M.Tech. and Ph.D. Degree Programme under Different Schemes at IARI, New Delhi for Academic Session 2022-23.

STEP 1: Type "<http://pgs.iasri.res.in/index.aspx>" on your browser and hit enter (Best viewed on Google Chrome) and click on "Filling up of Application Form and Uploading of Required Documents Online for M.Sc./M.Tech. and Ph.D. degree programme under Different Schemes for academic session 2022-23".

STEP 2: Click on "Register Here" button on the right side on the homepage.

STEP 3: Fill up the required details in the textbox on the page shown above and click on "Register" button.

STEP 4: After successful registration, click on "Login" button and enter your email ID and password you entered in Step 3 above. Change the password after the first login.

STEP 5: After successful login, a page will open with multiple text & dropdown fields.

STEP 6: Select your **Admission Scheme** from the "Scheme" dropdown. Fill-up all the other details as required and also fill the contact details: Then click on "Save and Next" button.

STEP 7: After clicking save and next, a new page will open in which **Education Details** have to be filled. After filling all the required details, click on "Save and Next" button to proceed further.

STEP 8: After successfully filling the education details, **Upload Image, Signature and Documents Page will open**, Here the applicant needs to upload his/her photo on "Image Upload" button, Click on "Choose File" and upload your photograph. The candidate's photograph should be less than 100 kb and greater than 10 kb. After uploading photograph, the candidate has to upload **his/her signature**. Here the applicant needs to upload his/ her signature on "Signature Upload" button below. The candidate's signature has to be less than 20 kb and greater than 10 kb. The Candidate has to upload all the requisite documents starting from Matriculation to Qualifying Degree Examination.

STEP 9: After uploading the photo signature and documents, click on "**upload**" button. After successful **upload**, a message will appear "Upload status: Images uploaded!". Click on "Next" button on the right side of the same page.

STEP 10: After clicking "Next" button, a page asking for **Payment Details** will appear. Here you will enter the Online Transaction details (UTR No.) of the application fee for the M.Sc./M.Tech. and Ph.D. degree programme under Different Schemes for the academic session 2022-23. **Application Fee (non-refundable) is Rs. 400 (Rupees Four Hundred only) for all Schemes/Categories**. After filling all the necessary details, click on "Save and Next" button.

STEP 11: After clicking "Save and Next" button, preview of your application will appear. Here you can review all your details that have been filled. After checking all the details check the declaration checkbox on the bottom of the page. After checking the check box, a Final Submit button will appear below the checked box Click on button. After clicking on **Final Submit button**, an alert window will open asking for confirmation for submission. Click on "OK" to submit your application.

STEP 12: After clicking "OK" a page with application form will open Click on "Print" to print the form.

STEP 13: After successful submission, the candidate should take a printout of the online submitted Application Form for future reference.

STEP 14: Please note that **Application Fee** shall be submitted **ONLINE** only as per the Payment Details uploaded on the Portal.

STEP 15: In order to avoid last minute rush, the candidates are advised to apply early enough. The IARI will not be responsible for network problems in filling up/uploading of required documents and final submission of the application form online or any other problems of this nature in submission of the online application form during last days.

Note: The details once submitted cannot be changed later on. Therefore, ensure that you have filled in the correct and complete information before final submission of application form.

Education Qualification and other Eligibility Requirements for Different Schemes

The candidates declared/notified as eligible for counseling by ICAR/NTA, based on their merit-rank, shall fill up Application Form and upload required documents online for M.Sc./M.Tech. and Ph.D. degree programme under Different Schemes as per instructions given above. Candidate shall forfeit the claim for admission if he/she, does not fill up application form and upload required documents within the specified date and time. **Those candidates who have scored zero or negative marks or have not been declared/notified as eligible for counseling, shall not be considered for admission under Different Schemes at IARI, New Delhi for the academic session 2022-23 at any stage.**

(ii) Documents related to Eligibility Requirements shall not be checked during the filling up of application form online but will be verified after the filling up of Application Form/uploading of required documents process is over. Candidates are required to ensure that they fulfill all the eligibility and document requirements for the Sub-subject at IARI, New Delhi as given in the AIEEA (PG)-2022 and ICAR AICE-JRF/SRF(Ph.D.)-2022 Information Bulletin respectively available on www.icar.nta.nic.in website. Candidates will be solely responsible for their fulfilling of and compliance to these eligibility and document requirements. The IARI will not entertain any claims arising out of their failure to comply with these requirements even at a later stage.

(iii) **The Merit list will be prepared for each of the Scheme separately for the eligible candidates who will fill up application form and upload required documents Online.** The Candidate will be provisionally recommended for admission in the Sub-subject under a Major Subject Group at IARI, New Delhi on the basis of their "**OVER ALL RANKING**" across the Disciplines secured in the AIEEA (PG)-2022 and ICAR AICE-JRF/SRF(Ph.D.)-2022 Entrance Examination conducted by NTA for M.Sc./M.Tech. and Ph.D. respectively.

(iv) Candidates who have been found qualified in the entrance examination AICE-JRF/SRF (Ph.D.)-2022 and AIEEA (PG)-2022 for Ph.D. and M.Sc./M.Tech. degree programme respectively conducted by NTA/ICAR are eligible to fill up application form and upload required documents under Different Schemes at IARI, New Delhi for the academic session 2022-23.

(v) The candidates passed out from Govt./Private Agricultural Colleges/Universities not accredited by ICAR, even though constituent or affiliated to public funded/Govt. institutions, were notified through Information Bulletin AIEEA (PG)-2022 and ICAR AICE-JRF/SRF(Ph.D.)-2022 as **not eligible to appear in AIEEA examination**. Therefore, if any of such candidates have appeared in the examination and their scores declared by NTA, are still **not eligible to fill application form and upload required documents**.

(vi) In case any degree from a particular College/University being derecognized by VCI/UGC, or due to any court directives (present or future), IARI will not admit such candidates of that College/University.

Rest of the rules/regulations as given in the Information Bulletin ICAR AICE-JRF/SRF(Ph.D.)-2022 and AIEEA (PG)-2022 (www.ntaicar.nic.in/ www.nta.ac.in) shall be applicable for admission to Ph.D. and M.Sc./M.Tech. degree programme under Different Schemes at IARI.

DIFFERENT SCHEMES

1. Faculty Upgradation Scheme (FUS)

Number of Seats: 10 for Ph.D. Degree Programme ONLY

- i. The Faculty Members should be qualified in ICAR AICE-JRF/SRF(Ph.D.)-2022 Examination conducted by NTA.
- ii. The Faculty Members applying under this scheme should be regular employees of the State Agricultural Universities (SAUs).
- iii. Not more than three candidates of any one State Agricultural University shall be admitted in any one year under this Scheme.
- iv. Rest all Education Qualifications and Eligibility Requirements as per Information Bulletin ICAR AICE-JRF/SRF(Ph.D.)-2022.
- v. The Sponsorship Certificate/Declaration as given in Information Bulletin ICAR AICE-JRF/SRF(Ph.D.)-2022 and Instruction Manual at **Annexure- XIX and Annexure-I** respectively should be submitted.

2. ICAR-In Service Scheme

Number of Seats: 10 for Ph.D. Degree Programme ONLY

- i. The Scientists should be qualified in ICAR AICE-JRF/SRF(Ph.D.)-2022 Examination conducted by NTA.
- ii. The candidates applying under this scheme should be Scientists working in ICAR Institutes.
- iii. Rest all Education Qualifications and Eligibility Requirements as per Information Bulletin ICAR AICE-JRF/SRF(Ph.D.)-2022.
- iv. The Sponsorship Certificate/Declaration as given in Information Bulletin ICAR AICE-JRF/SRF(Ph.D.)-2022 and Instruction Manual at **Annexure- XIX and Annexure-I** respectively, should be submitted.

3. Departmental (Scientific and Technical) Scheme

Number of Seats:

- i) Departmental (Scientific): 10 seats for Ph.D. degree programme ONLY
 - ii) Departmental (Technical): 5 for Ph.D. Degree Programme
5 for M.Sc./M.Tech. Degree Programme
- i. The Candidates should be qualified in ICAR AICE-JRF/SRF(Ph.D.)-2022 and ICAR AIEEA(PG)-2022 Examination for Ph.D. and M.Sc./M.Tech. Degree programme respectively, conducted by NTA.
 - ii. Candidates applying under this scheme should be Scientists and Technical Personnel working at IARI, New Delhi and its Regional Stations/ICAR-IASRI, New Delhi/ICAR-NBPGR, New Delhi/ICAR-NIPB, New Delhi.
 - iii. Rest all Education Qualifications and Eligibility Requirements as per Information Bulletin ICAR AICE-JRF/SRF(Ph.D.)-2022 and ICAR AIEEA(PG)-2022 Examination for Ph.D. and M.Sc./M.Tech. Degree programme respectively.
 - iv. The Sponsorship Certificate/Declaration as given in Information Bulletin ICAR AICE-JRF/SRF(Ph.D.)-2022 and Instruction Manual at **Annexure- XIX and Annexure-I** respectively, should be submitted.

4. Children/Widows of Security Forces (CWSF) Scheme

Number of Seats: 05 Seats (02 for Ph.D. degree programme and 03 for M.Sc./M.Tech.)

(The number of seats for admission to M.Sc./M.Tech. and Ph.D. is inter-changeable in case of non-availability of candidates in that particular degree programme).

- i. The Candidates should be qualified in ICAR AICE-JRF/SRF(Ph.D.)-2022 and ICAR AIEEA(PG)-2022 Examination for Ph.D. and M.Sc./M.Tech. Degree programme respectively, conducted by NTA.
- ii. Candidates applying under this scheme should be Children/Widows of Security Forces.
- iii. Rest all Education Qualifications and Eligibility Requirements as per Information Bulletin ICAR AICE-JRF/SRF(Ph.D.)-2022 and ICAR AIEEA(PG)-2022 Examination for Ph.D. and M.Sc./M.Tech. Degree programme respectively.
- iv. The Requisite Certificate for CWSF Category as per Concerned Department/Govt. of India should be submitted.

- ii. Candidates applying under this scheme should be **Wards of Kashmiri Migrants and Kashmiri Pandits/ Kashmiri Hindu families (Non-Migrants) living in Kashmir Valley.**
- iii. Rest all Education Qualifications and Eligibility Requirements as per Information Bulletin ICAR AICE-JRF/SRF(Ph.D.)-2022 and ICAR AIEEA(PG)-2022 Examination for Ph.D. and M.Sc./M.Tech. Degree programme respectively.
