Technical Specification for the Purchase of Digital PCR System

- 1. Table Top Model with advanced technology of droplet/ Plate/ Chip based PCR quantitation.
- 2. System should have water-oil emulsion droplet generator/ physical partition / micro-chamber with microfluidic technology.
- 3. System should be able to generate 20,000 or more uniform nanolitre droplets/ partitions from each reaction mix.
- 4. Reaction volume 25 microliter or less.
- 5. Sample capacity minimum of 8 samples per run.
- 6. Dynamic range should be 4 orders or more.
- 7. System should have capability of atleast 4 target multiplexing per well.
- 8. Able to read multiplexing assays run with probe based as well as dye based chemistry.
- 9. System should perform absolute quantification of nucleic acids with high precision without use of reference genes as well as standard curves.
- 10. Software package used for the digital PCR system should be freely used in different computer systems.
- 11. The reader must be able to read fluorescence data from each single droplet / partition individually.
