Notes :

- (i) The Payment shall be made on conclusion of the calendar month only on the basis of number of days for which duty has been performed by each manpower.
- (ii) The Service Charges should not be less than Rs.500/- (Rs. five hundred only). The Service Charges should be quoted in Rupees not in percentage; otherwise the same will be rejected.
- (iii) The IARI will reimburse all statutory payments as per minimum Wages, as applicable from time to time. The bill to be preferred on a monthly basis. The firm should therefore enclose copies of wage register, attendance sheet, bank statement, challans and ECRs towards statutory payments (EPF, ESI etc.) made by it for reimbursement.
- (iv) The service charges quoted by the agency/bidder under the Column No.-04 of Financial Bid/BOQ shall remain unchanged through out the entire period of the contract, however, the minimum wages & other statutory liabilities shall be revised as per the notifications/orders issued by Govt of India/Govt of NCT of Delhi from time to time, during the contract.
- (v) The Financial Bid should be quoted only in BOQ format and not anywhere else in the tender document, else, the same will be summarily rejected.
