- e) The Prices shall be quoted in Indian Rupees only.
- 4. Each bidder shall submit only one quotation. Bidder shall not contact other Bidders in matters relating to this Quotation.

# 5. Validity of Quotation

Quotation shall remain valid for a period not less than 15 days after the deadline date specified for submission.

## 6. Evaluation of Quotations

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

Sales tax in connection with sale of goods shall not be taken into account in

evaluation.

7. Award of contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
- 7.3 Successful Bidder should submit 10% of Total Cost of Equipment as Performance Guarantee after receiving the Purchase/Supply Order.
- 8. Payment shall be made immediately after delivery of the goods.
- Normal commercial warranty/ guarantee shall be applicable to the supplied goods.

## **Technical Specifications of BOD Incubator**

- BOD Incubators should be suitable for Microbial cultivation and other biological experiments
- Outer wall should be made of double walled MS Sheet finished with epoxy-based powder coated paint.
- 3. Inner chamber should be made of highly polished stainless steel
- 4. Incubator must have two doors, an outer and inner. Inner door should be of transparent acrylic for inspecting the specimens; outer door should be insulated and is fitted with magnetic tape with lock and key.
- BOD INCUBATOR should be provided with 304 grade stainless steel inner body with PID controller & display. Inner chamber must have lighting system.
- 6. The system should have a temperature range of 5°C to 50 °C with an accuracy of +1 °C, it should provide two air circulating fans, high performance compressor, cooling coils, heating elements, digital temperature control and display.
- 7. It should also fit with a door operated illumination and a caster wheel with lock system for easy mobility and locking.
- 8. Volume should be 5.0 to 8 cft
- 9. Must be supplied along with high quality voltage stabilizer
- 10. Must have atleast five to ten users and user satisfaction certificate
