Government of India has received a financing from the World Bank towards the cost of the said Equipment/Item **under NAHEP-CAAST (71-01) Project** and intends to apply part of the proceeds of this financing to eligible payments under the contract for which this invitation for quotations is issued.

3. **Bid Price**

- The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and re writing.
- All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
- Sales tax in connection with the sale shall be shown separately.
- The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- The Prices shall be quoted in Indian Rupees only.

4. Each bidder shall submit only one quotation. Bidder shall not contact other Bidders in matters relating to this Quotation.

5. **Validity of Quotation**

Quotation shall remain valid for a period not less than 15 days after the deadline date specified for submission.

6. **Evaluation of Quotations**

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) are properly signed ; and
- (b) conform to the terms and conditions, and specifications.

The Quotations would be evaluated for all the item together/would be evaluated separately for each item. *[Select one of the options]*.

**Sales tax in connection with sale of goods shall not be taken into account in evaluation.**

7. **Award of contract**

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 7.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 7.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
- 7.3 **Successful Bidder should submit 10% of Total Cost of Equipment as Performance Guarantee after receiving the Purchase/Supply Order.**

8. Payment shall be made immediately after delivery of the goods.

9. Normal commercial warranty/ guarantee shall be applicable to the supplied goods.

## Annexure -A

### **Technical Specifications of Fume Hood**

1. The system should be floor mounted with aerodynamic design.
2. Dimension should be approximately 4-6 x 2-4 x 2-4 feet.
3. Air Flow Type: Automatic Bypass Type.
4. Construction: Epoxy powder coated galvanized steel structure.
5. Space should be provided underneath as storage compartment as provision of gas and air connection storage.
6. Worktop should be chemical or corrosion resistant and spillage proof granite. Sink, and water tap with drain arrangement must be available.
7. Vertical sliding counter balanced toughened glass /polycarbonate fitted with the powder coated aluminum.
8. Lighting must be LED with poly carbonate encloser for better illumination.
9. All necessary electrical fittings and socket must be available with fume hood.
10. Control panel should be provided with starter for blower. Complete rigid structure to support fume hood. Double skin shutter with self-closing hinges.
11. Centrifugal Blower should be silent, highly efficient, consisting of continuous rating motor for exhaust system and duct to remove fumes.
12. The system should have 2-point suction section with baffle to ensure smooth and immediate exhaust of fumes.
13. The hood must be built as per ASHRAE (American Society of Heating, Refrigerating and Air-Conditioning Engineers) and European norms.
14. Must be supplied with suitable voltage stabilizer
