

The contractor must have valid IT-PAN/VAT/TIN and GST registration number and having experience of two similar nature of works in last three years for the work mentioned below. The Tender shall be processed in two bid system (Technical bid & Financial bid) for purchase of following Scientific Equipment/Items. The last date for submission of Bid 15-01-2021 at 15.00 hrs. The Technical bid will be opened on dated 16-01-**2021** at 15.00 hrs by the prescribed committee.

बोली लगाने के निर्देश और नियम एवं निविदा की शर्ते Instructions to the bidder and terms & conditions of tender:

आपके द्वारा दी गयी मूल्य दर क्यूटेशन प्राप्ति हेतु निर्धारित अन्तिम दिन से कम से कम 180 दिनों तक मान्य होगी। यदि आपूर्तिकर्ता द्वारा 180 दिनों की न्यूनतम अविध की वैधता के संबंध में कोई अन्तर हो तो उसका विशेष रूप से उल्लेख होना चाहिए। The rates quoted shall be valid for a minimum period of 180 days from the last date fixed for submission of bid.

The details of D.D./Pay Order/Fixed Deposit Receipt/Bank Guarantee physically sent, should tally with the details available in the scan copy and the data enter during the bid submission time otherwise the uploaded bid will be rejected इस संस्थान द्वारा निविदाकर्ता को किसी भी सुरक्षा जमा राशि और बयाना राशि पर ब्याज नहीं दिया जाएगा। No interest on security deposit and earnest money deposit shall be paid by the Institute to tenderer.

In case of successful bidder, it can be adjusted towards security deposit which is 10% of the order value in the form of D.D./Pay Order/Fixed Deposit Receipt/Bank Guarantee from commercial bank drawn in favour of Director, IARI payable at New Delhi and shall remain valid for 60 days beyond the date of completion of all contractual obligation of supplier including warranty obligation for the equipment/goods costing Rs.1.00 lakhs (Rs. One Lakh) or more. There would however, be no performance security deposit for equipment/goods costing less than Rs. 1.00 lakh (Rs. One Lakh).

- 11. TIN/GST/VAT/PAN/C.S.T. Nos. के स्कैन कॉपी को क्यूटेशन के साथ में संलग्न किया जाए। Scanned copy of TIN/GST/VAT/PAN/C.S.T. Nos may be attached with the bid.

16. The following documents must be furnished with the technical bid failing which tender will not be accepted at all.

- 1. GST/Registration Certificate/ISO Certification etc.
- 2. Pan Card copy.
- 3. Earnest Money Deposit (EMD) Rs.19,000/- (Rupees Nineteen Thousand Only). Firms duly registered with NSIC,MIS,MSE(for manufacturing) shall be exempted from submitting EMD as per Govt. instructions in force.
- 4. Literature/pamphlet/Catalogue/Technical Brochure drawing etc. alongwith user list
- 5. Experience: Two work order of similar nature on yearly basis for the last 03 years. (Means six order for 03 years).
- 6. Turn Over of the firm should be minimum Rs.50 lakh per year for the last 3 years (2017-18, 2018-19, 2019-2020) enclosed with technical bid.
- 7. Income Tax latest return to be attached.
- 8. Advance Samples of Poly sheet & GI Pipe must be submitted. Samples must be carefully packed, sealed and labelled clearly with tender number and sender's name. Rejected samples will be returned at bidder's cost if insisted advance sample should be submitted between 1400 hrs and 1600 hrs in the plant Pathology Division on or before 15-01-2021 alongwith EMD physically before closing date.
- 9. The tender documents duly signed by the Authorized signatory of the quoting firm accepting the same should be attached with technical bid.

17. Terms & Conditions

- 1. Tender should be submitted in two bid system i.e. Technical Bid and Price Bid. Price Bid of only those bidders shall be opened who have been declared technically qualified. Financial bids of bidders who are declared technically not qualified as per tender specification & Tech commercial conditions will not be opened.
- 2. The firm should have a minimum experience of 10 years for construction of NVPH/Green Houses/ Polycarbonate Houses. Proof should be enclosed.
- 3. Turn Over of the firm should be minimum Rs. 50 lakh per year for the last 3 years (Proof should be enclosed).
- 4. The firm must have ISO Certificate.
- 5. Income Tax latest return to be attached.
- 6. Prices/Rates should be quoted in INR only. Prices quoted in any other currency should not be acceptable. Prices should be quoted both in words & Figures.
- 7. Bidder should submit a declaration/ undertaking that the firm/company has not been blacklisted or debarred by any Government Deptt/ Institute and no dispute is pending with any Government Deptt/ ICAR Institute.
- 8. Fall clause: Bidder shall given a declaration/ undertaking that the Prices quoted/ charged for the supplies made/ work executed under the contract shall under no circumstances exceed the lowest prices at which contractor sells the stores of

identical description to any Government Deptt/ Institute/ Public enterprises during the period of contract.

9. Period for Completion of work: 02 months from the date of issue of work

- 10. In case deliveries are not maintained by the contractor on whom order is places and resultantly the purchase in forced to buy the material and get the work done at your risk and cost from elsewhere, the loss or damage that may be sustained there will be recovered from such defaulting contractor.
 - 11. Mode of payment: Payment will be released after satisfactory completion of work duly certified by the concerned scientist.
- 12. Our normal payment terms are 100% within 30 Days of receipt and acceptance of material/satisfactory completion of work at site.
- 13. Period of Guarantee/Warranty: One year from the date of completion of work.
- 14. Performance Security: The successful bidder will have to submit a Performance Security of equivalent to 10% of the contract/order value within one week of issue of award letter. The Performance security in the shape of Bank Guarantee/DD/FDR should be drawn in favour of Director, New Delhi and should be kept valid for a period of 60 days beyond the completion of work date and fulfilment of all contractual obligations by the Contractor.
- 15. Liquidated Damages: In case the firm does not complete the installation within the laid down agreed seurity delivery period as per contract, liquidated damages will be charged @0.5% per week or part thereof subject to a maximum of 10% of the contract value. However, the Institute reserves the right to either further extend or cancel the contract after expiry of delivery date and recover the liquidated damages from the dues of the firm or by legal means.

16. Dispute Settlement: The dispute arising out of this contract shall be subject to the jurisdiction of Indian laws & court at New Delhi. Sole arbitrator is appointed by the Secretary, ICAR, New Delhi. His decision will be final and binding to both parties (supplier and

Purchaser).

17. Force Majeure Clause: The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure. For purposes of this clause, "Force Majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such event may include, but are not limited to, acts of the purchaser eigher in its sovereign or contractual capacity, wars or revolutions, fires, floods, Epidemics, quarantine restrictions, strikes, lockout or any act of war. Notice of the happening of any such event is given by either party to the other within 15 days from the date of occurring thereof. The contractor has to give notice of force Majeure. In a similar situation with the purchaser, where purchaser is unable to receive supplies at his site due to FM condition, Purchaser can also make a communication accordingly. If the performance in whole or in part is prevented or delayed by any reason of FM for a period exceeding 90 days, either party may at its opinion terminate the contract without any financial repercussion on either side. Notwithstanding the punitive provisions contained in the contract for delay or breach of contract, the supplier would not be liable for imposition of any such sanction due to delay occurring covered in FM clause.

18. Tender document duly stamped and signed by the authorized signatory on each page should be returned with the Tender in token of having accepted all the Terms and Conditions of this tender.
