

- 4. Bidder must have following certificates with the pre-qualified documents.
- i. ISO 9001-2015
- ii. BIFMA Membership Certificate
- 5. Bidder should possess GST Registration, Certificate of Incorporation, Provident Fund Certificate, Employee State Insurance Corporation certificate.
- 6. The bidder should be enclosed the documentary proof of up-to date GST return, EPF challan and ESIC challan with tender bid.
