# Technical Specifications of Dry bath with shaking for microfuge tubes

- 1. Dry bath with LCD display and designed for simultaneously heating, cooling and mixing of small samples.
- 2. Should have minimum dimensions (L x W x H) mm 300 x 220 x170
- 3. Should have mixing orbit of 2mm
- 4. Should have capacity to accommodate 0.2, 0.5, 1.5ml, 2.0 ml & microplate block.
- 5. Should have temperature control range of RT+ 5°C to 100°C
- 6. Should have temperature setting range of 5°C to 100°C
- 7. Customized blocks should available to suit specific demands & should provide Genital, reliable mixing with long-life direct current motor.
- 8. Should have timing range of 1min to 99h59min
- 9. Should have temperature control accuracy of  $\pm 0.5$  °C
- 10. Should have display accuracy of 0.1°C
- 11. Should have heating time (20°C to 100°C) of ≤15min
- 12. Should have mixing speed of 200-1500rpm
