Annexure -I

Specification for Photoperiod and temperature controller, Humidifier and controller

- An ergonomically designed heavy-duty (at least 52kg weight) humidifier that can maintain relative humidity (RH) of the plant growth chambers/greenhouses according to set values ranged 0 to 85%
- 2. This plug-and-play humidifier system should have the capacity to store at least 15 litres of water in the inbuilt storage tank and nebulize water into fine particles at the rate of 23000 ml/hr to maximum of 24000 ml/hr to cover 1000 square feet of greenhouse coverage area along with complete set of suitable switches, electric protection, water connection point, overflow point, etc.
- 3. The body material should be Stainless Steel 304.
- 4. Electrical component of the humidifier should be a reliable, transformer-based system.
- 5. The system should be able to monitor the relative humidity (0-85%) of the greenhouse/ growth chambers and operate at a noise level of < 40 dB.
- 6. The humidifier system should have the provision to integrate with the centralized control system of the greenhouse for turning on/off depending on the RH sensed by the greenhouse sensors.
- 7. The humidifier should have an energy-efficient system to nebulize the water at a rate of no more than 1200 watts.
- 8. The humidifier should be portable with sturdy caster wheels.
- 9. The humidifier should be supplied with at least 12 months of warranty.
- 10. Product should be a standard catalog item.

Terms and conditions:

- 1. This is a nil deviation bid. The product has to strictly adhere to the given specifications.
- 2. The bidder should have ISO 9001:2015 certification. Certificate copy to be attached with the bid.
- 3. Manufacturer certificate of OEM
