double duty. Some of the important items or situations that have to be covered by security services of the company are enumerated below:-

## 1. Regulation of Entry/Exit of Visitors:-

- 1.1 Regulate access control on all gates so as to prevent misuse of IARI grounds and facilities by outsiders, neighbours and thus, prevent tress-passing.
- 1.2 Day and Night patrolling on regular basis across the boundaries of the entire area covered in this tender shall report any unusual events in suspicious circumstances occurring in the area/campus.
- 1.3 To check ID cards of all visitors entering in the campus and make necessary entries in proper registers wherever required.
