  Commissioning and installation in accordance with the requirements stated in the bid.
  - An Earnest Money Deposit [Bid Security] of Rs. 30,000/- (Rupees Thirty thousand only) must be deposited (physically) in the form of Demand Draft/Pay Order/FDR payable to In favour of Director, ICAR-Indian Agricultural Research Institute payable at New Delhi 110012 to Asstt. Admn. Officer, Division of Microbiology (in the office), ICAR-IARI, New Delhi -110012 on or before the last date/time of submission of GeM Bid.
  - Exemption from EMD submission is meant for procurement of only goods produced and service rendered by MSEs and not for any trading activities by them.
  - The rates quoted by each firm for this in bid should be valid for 180 days and should be quoted both in words and figures failing which the same is liable to be rejected.
  - No request for alteration in the rates once quoted will be permitted.
  - > The rates to be quoted should include cost of each and every item including transportation cost, manpower cost and taxes etc. The IARI shall not bear any extra charge for the same.

  - If Vendor does not accept the offer, after issue of letter of award by IARI within 01 day, the offer made shall be deemed to be withdrawn without any notice & earnest money forfeited.

An amount @ 10% of the estimated value of contract is to be deposited by the selected firm/ successful Vendor as Performance Security Deposit (Performance Bank Guarantee) only after issuance of Supply order through GeM portal/this office. In the event of non-deposition of the same, the earnest money will be forfeited. No interest on Earnest Money (EMD) and Performance Security Deposit (Performance Bank Guarantee) shall be paid by the IARI to the Vendor.

### Specifications for Deep Freezer (Revised)

- 1. Upright deep freezer with minimum capacity of 400-450 liters.
- 2. Freezer should have temperature of -80°C.
- 3. Instrument temperature accuracy should be 1°C
- 4. Instrument temperature stability at -80°C should not be more than +/- 2°C and relative humidity should be less than 80% RH.
- 5. High density door insulation/vacuum insulation panel and stainless-steel interior.
- 6. Heavy gauge steel exterior with powder coating or rust-free coating.
- 7. With least power consumption and noise level less than 56Db.
- 8. Freezer should have microprocessor control panel/diagnostic control panel with all control panel and display, audible and visible alarm for temperature, power, system failure. Optional condensor fault alarm, door open alarm, closed filter alarm.
- Freezer should have individual 3-5 stainless steel compartments with individual inner doors to avoid cold air loss.
- 10. Vacuum relief port for easy opening of door.
- 11. Heavy duty lockable casters and lockable door handle.
- 12. Freezer should have heated air vent and front panel air filter.
- 13. Freezer must have CFC-FREE, HCFC-FREE nonflammable refrigerants and should provide cascade free coding.
- 14. Instrument minimum temperature should be able to hold at 32°C after power cut off.
- 15. Power management to avoid wide range of voltage fluctuation.
- 16. Freezer should come along with at least 5KVA voltage suitable stabilizer.
- 17. Freezer should have CE and ISO Certification (certificate should be provided).
- 18. Freezer should have single phase power supply 230V,50HZ.
- 19. Optional system should be provided with CO2 cylinder, controller and regulator.
- 20. Service Team should be available locally to respond within 5 hrs. for any breakdown in the machine
- 21. Freezer Should have minimum 02 years of warranty and compressor should have minimum 05 year of warranty from the date of satisfactory installation report.
- 22. Freezer should be provided along with user manual and user list.
- 23. Vendor should be able to provide demonstration in Delhi NCR.
