## Quotations shall satisfy the following:-कोटेशन निम्नलिखित को पूरा करेगा:

- 1. The rates quoted shall be valid for a period of 180 days from the last fixed for the receipt of quotations.
- 2. The rates quoted shall be free of cost delivery and installation at the **Zonal Technology Management** and **Business Planning & Development Unit, IARI, New Delhi-110012**. However, equipment quoted in foreign currency must be quoted on FOB/ CIP basis.
- 3. Full specifications of the article quoted for, shall be given in the prescribed format only along with illustrated pamphlets/drawings etc. where available, wherever possible.
- 4. If taxes, duties or any other charges over and above the rates quoted are leviable by the purchaser, actuals/percentage of such taxes/duties/charges should be clearly indicated.
- 5. If the bid is submitted by the authorized dealer on behalf of the Manufacturer/OEM, than valid authorization certificate of the Manufacturer/OEM must be attached with the bid, otherwise bid will not be considered.
- 6. The bid should accompanied with EMD of Rs.7,000/- (Rupees Seven Thousand only) in form of D.D./Deposit Receipt/Bank Guarantee from commercial bank drawn in favor of Director, IARI payable at New Delhi. The original EMD should be submitted to the Tender Inviting Authority on or before the last date and time of bid submission. The details of D.D./Pay Order/Fixed Deposit Receipt/Bank Guarantee physically sent, should tally with the details available in the scan copy and the data enter during the bid submission time otherwise the uploaded bid will be rejected.

- 7. No interest on security deposit and earnest money deposit shall be paid by the Institute to tenderer.
- 8. The EMD shall be refunded to the unsuccessful bidders after finalization of the quotation. In case of successful bidder, it can be adjusted towards security deposit which is 5-10% of the order value in the form of D.D./Pay Order/Fixed Deposit Receipt/Bank Guarantee from commercial bank drawn in favor of Director, IARI payable at New Delhi and shall remain valid for 60 days beyond the date of completion of all contractual obligation of supplier including warranty obligation for the equipment/goods costing Rs.1.00 lakhs (Rs. One Lakh) or more. Here would however, be no performance security deposit for equipment/goods costing less than Rs. 1.00 lakh (Rs. One Lakh).
- 9. One year warranty has to be invariable provided by the firm. In case, there is any variation in the warranty period given in the specification of the item/equipment, the warranty period shall be the final as given in the specification.
- 10. Scanned copy of TIN/VAT/PAN/G.S.T. Nos may be attached with the bid.
- 11. Payment will be made by mode of e-payment on satisfactory completion of supply and receipt of pre-receipted bills in triplicate.
- 12. Director, IARI, New Delhi reserves the right to accept or reject any or all the quotations either in full or in part without assigning any reason.
- 13. Quotations not complying with the above conditions are liable to be rejected.
- 14. The successful bidder has to execute the indented Job/Work as mentioned in the supply order placed with them within the stipulated period as given in the supply order placed by this office failing which 2% per week and maximum of 10% deduction as liquidated damage charges will be made from the bill in case the job is not completed within the given stipulated period.
- 15. In case, any dispute arising out of this contract shall be subject to the jurisdiction of Indian laws & Court at New Delhi. Sole arbitrator is appointed by the Secretary, ICAR, New Delhi. His decision will be final and binding on both parties (Supplier and Purchaser).
- 16. If price is quoted in foreign currency than only CDEC will be provided to the firm (if needed). Further EMD exemption can only be provided to manufacturing firms only not tenderer. EMD exemption can only be provided to Indian manufacturer registered under MSME/NSIC on production of valid documents applicable under GFR/MOP of GoI.
