**बोली लगाने के निर्देश और नियम एवं निविदा की शर्तें Instruction to the bidder and terms & conditions of tender:**

1. बोलीदाता कृपया ध्यान दें कि वाणिज्य और उद्योग मंत्रालय , उद्योग और आंतरिक व्यापार को बढ़ावा देने के विभाग, सरकार के आदेश के अनुसार वरीयता “मेक इन इंडिया” को दी जाएगी। उत्पाद की तकनीकी उपयुक्तता के अधीन। Bidders may please note that Preference will be given to “Make in India” as per order of Ministry of Commerce and Industry, Department of promotion of Industry and Internal Trade, Govt. of India subject to technical suitability of the product.
2. कोटेशन में दर्शायी गई दरों में भा . कृ .अनु .सं.नई दिल्ली के संभाग कृषि अभियांत्रिकी संभाग/भारतीय कृषि अनुसंधान संस्थान , नई दिल्ली -110012में सामान सामग्री की नि : शुल्क आपूर्ति अथवा स्थापन शामिल होगा। हालाँकि विदेशी मुद्रा में दर्शाए गए उपकरण को एफ ओ बी आधार पर दर्शाया जाये। The rates quoted shall be free of cost delivery and installation at the Division of Agricultural Engineering, IARI, New Delhi-110012. However, equipment quoted in foreign currency must be quoted on FOB.
3. हमारा संस्थान कस्टम ड्यूटी से मुक्त है। इसलिए कस्टम ड्यूटी छूट प्रमाण पत्र (सी.डी.ई.सी) फर्म को प्रदान किया जाएगा, अगर मांग की जाती है। Our Institute is exempted from Custom Duty. Hence Custom Duty Exemption Certificate (CDEC) will be provided to the firm, if demanded.
4. उपरोक्त दिए गए दर में यदि किसी भी प्रकार का अतिरिक्त कर /टैक्स/ड्यूटी लगाया जाना है तो उसका संकेत स्पष्ट रूप से दिया जाना चाहिए। If taxes duties or any other charges over and above the rates quoted leviable, actual percentage of such taxes/duties/other charges should be clearly indicated.

5. इस संस्थान द्वारा निविदाकर्ता को किसी भी सुरक्षा जमा राशि पर ब्याज नहीं दिया जाएगा। No interest on security deposit shall be paid by the Institute to tenderer.
6. कोटेशन प्रक्रिया पूरी होने के पश्चात सफलतम बोलीदाता के मामले में सुरक्षा जमा राशि के रूप में, जो कि आडर के राशि की 3% होगी और यह डिमांड ड्राफ्ट / भुक्तान आदेश / मियादी जामा रसीद / बैंक गारंटी, निदेशक, भा. कृ. अ. स. नई दिल्ली 110012 के नाम किसी भी राष्ट्रीय बैंक में देय हो, जिसकी वैधता सभी कार्य को पूरा करने के दिनों 60, उपकरण की एक वर्ष की गारंटी के साथ उपकरण / सामान/ जिसकी कीमत रु. 1.00 लाख या इससे अधिक की गारंटी होगी। हालांकि जो उपकरण रु 1.00 लाख या एक लाख से कम है उस परिस्थिति में किसी भी प्रकार का निष्पादन जमा राशि नहीं दी जाएगी। In case of the successful bidder after completion of the quotation process, in the form of security deposit amount which will be 3% of the order amount D.D/Pay Order/Fixed Deposit Receipt/Bank Guarantee from commercial bank drawn in favour of Director, IARI, payable at New Delhi and shall remain valid for 60 days beyond the date of completion of all contractual obligation of supplier including warranty obligation for the equipment/goods costing Rs. 1.00 lakhs (Rs. One Lakh) or more. Here would however, be no performance security deposit for equipment/goods costing less than Rs. 1.00 lakh (One lakh).

In case, there is any variation in the warranty period given in the specification of the item/equipment, the warranty period shall be the final as given in the specification.

10. उपरोक्त शर्तों का पालन न करने वाली क्यूटेशनों को अस्वीकार कर दिए जा सकते हैं। Quotations not complying with the above conditions are liable to be rejected.
11. TIN/VAT/PAN/C.S.T./GST Nos. के स्कैन कापी को कोटेशन के साथ में संलग्न किया जाए। Scanned copy of TIN/VAT/PAN/C.S.T./GST Nos may be attached with the bid.
12. किसी कारण अनुबंध में कोई विवाद उत्पन्न होने पर भारतीय कानून और न्यायालय नई दिल्ली की अधिकारिता के अधीन होगा। सचिव भारतीय कृषि अनुसंधान परिषद द्वारा एक मात्र मध्यस्थ नियुक्त किया गया है जिसका निर्णय दोनों पार्टियों (Supplier and Purchaser) पर अंतिम माना जाएगा। In case, any dispute arising out of this contract shall be subject to the jurisdiction of Indian laws & Court at New Delhi. Sole arbitrator is appointed by the Secretary, ICAR, New Delhi. His decision will be final and binding on both parties (Supplier and Purchaser).

- with 2% per week and maximum of 10% deduction as liquidated damage charges will be made from the bill in case the job is not completed within the given stipulated period

  15. In Case, LC is opened for purchase of Foreign equipment all charges outside India will be borne by the firm.
  16. As per CVC's guidelines No.12-2-6CTE-SPJ(1)-2/161730 (circular No.3/1/12) dated 13/1/2012, in a tender either the Indian Agent on behalf of the Principal/OEM itself can bid but both cannot bid simultaneously for the same item/product in the same tender. Further, if an agent submits bid on behalf of the Principal/OEM the same agent shall not submit a bid on behalf of another Principal/OEM in the same tender for the same item/product.
  17. The equipment is to purchase for Research purpose and therefore shall be purchased at **concessional GST Rate of 5%**. The required certificate shall be issued to the successful bidder for availing concessional GST Rate.
  18. **Rates should be quoted as per BOQ 1 on-line.**
